- I understand that my selection of wines will be used as my preference for future deliveries and that vintages and prices may change and this will show up on my order.
- I understand that one wees prior to delivery I will receive a pre-delivery notification by email of my upcoming shipment during which time I can elect to choose my own selection of wine or change my delivery.
