TENTATIVE BOOKING & CONFIRMATION WITH DEPOSIT

A TENTATIVE BOOKING WILL BE HELD FOR 7 DAYS FROM THE TIME OF BOOKING. IF THIS PERIOD OF TIME LAPSES AND THE DEPOSIT PAYMENT AND SIGNED TERMS AND CONDITIONS HAVE NOT BEEN RECEIVED, CRAIGIE KNOWE VINEYARD RESERVES THE RIGHT TO RELEASE THE DATE FOR RE-SALE. IN ORDER TO CONFIRM, PLEASE RETURN A SIGNED COPY OF THE EVENTS CONTRACT TOGETHER WITH A NON-REFUNDABLE DEPOSIT OF \$1500

PAYMENT DETAILS
